Eligibility:

- The intending supplier/Agency should have Trade Registration Certificate, GST Registration Certificate, Valid PAN issued by Income Tax Department, Income Tax Return of Financial Year 2022-23

Credential required:-

- Certificate of completion or similar nature of work of total value of Rs. 2,00,000.00 in any year during last 5 years with any Govt./Su Govt. Agencies. However authority reserves the right to relax this value in case of insufficient number of bidders having such credentials.

Earnest Money:

- EMD of successful bidder/bidders will be retained till successful completion of supply.
- EMD of unsuccessful bidders will be automatically returned to the respective Bank Accounts of bidders.
- Process of deposit of Earnest money: Earnest Money must be deposited online during submission of Bid as per Order No: 3975-F(Y) dated. 28.07.2016 of Finance Department, Govt. of West Bengal.

Bid procedure:-

- Intending bidders shall have to bid online through the portal <https://wbtenders.gov.in>
- All documents as mentioned in "Eligibility", "Credential required" and certificate of declaration as mentioned at "Terms & Conditions" need to be uploaded.
- Financial Bid of bidders who do not meet eligibility criteria shall not be opened.
- There is no scope of submission of any document later if not uploaded during bid submission.

Selection of Successful Bidder:

- Bidder offering lowest rate against the item shall be considered as the successful bidder of that item.


Payment procedure:

- No advance or adhoc payment will be allowed.
- Payment may be made through Online mode or A/C Payee Cheque against successful completion of
- Supply/work as and when fund will be available in the respective head of account.
- Whether the supply is successful or not will be decided by the authority only.

Terms and condition:-

1. If successful bidder/ bidders fails/ fail to comply with the scope of the work then the authority may forfeit the EMD in full/ legal action may be initiated or in part and in addition may also blacklist the agency/ supplier for such period as may be considered by the authority.
2. The authority reserves the right to reject the tender or any part of the tender without assigning any reason whatsoever.
3. The authority reserves the right to issue supply order to more than one bidder for the same Item without assigning any reason whatsoever.
4. The rates quoted shall remain valid till completion of the entire election process.
5. The rates quoted shall remain valid till completion of the entire election process.
6. Any camera found defective or not as per our specification or more than the order for placed for will be rejected and no payment will be made for the same and the supplier/ agency will be bound to supply the same Camera as per correct specification by the specified time.


