1. The bidder of auction sale shall quote his bid in prescribed format obtained from this office and submit bid in sealed envelope and shall be addressed to **The Sub-Divisional Officer, Ranaghat Sub-Division, Government of West Bengal** and shall bear the following identification:
2. The intending bidders will have to submit application in the office of the undersigned for getting permission for participating in the auction by producing valid GST, P.T., latest IT return and PAN Card.
3. Last date for submitting application for obtaining permission and obtaining bid documents from this office is **28.07.2025 upto 4.00 PM.**
4. Last date of Permission of bid documents from this office on **28.07.2025.**
5. Bids will be received in the Office of the **Sub-Divisional Officer, Ranaghat Sub-Division,** on **29/07/2025 up to 4.00 P.M.**
6. All bidders must produce Bid Participation money as mentioned in the list of work in the shape of Bank Draft drawn on any scheduled Nationalized Bank in favour of **The Sub-Divisional Officer, Ranaghat Sub-Division,** No N.S.C., K.V.P. or fixed deposit will be entertained against the Bid Participation money. The Bid Participation money of successful bidder will be released after completion of lifting of auctioned materials within the schedule date of completion of the work. Any Bid not accompanied by acceptable Bid Participation money shall be rejected.

Bid Participation money shall be forfeited:

- a. If the Bidder withdraws his bid during the period of bid validity.
 - b. If the successful bidder fails to deposit full bid price within the stipulated time after issuance of acceptance letter.
 - c. In such of failure on the part of the bidder to cut and lift trees within the stipulated period.
7. The bidders shall quote their bid price both in figures and in words in prescribed format issued to them from this office against application. All bidders must inspect the trees, which are marked at site, thoroughly before quoting their rates on any working day.

Bid less than the Reserve Price will not be accepted.

8. The successful bidder will have to deposit full amount of bid money in the form of Bank draft drawn in any scheduled Nationalized Bank in favour of **The Sub-Divisional Officer, Ranaghat Sub-Division**, after acceptance of his bid.
9. All bidders shall submit attested copy of latest I.T. return, G.S.T. Registration Certificate and PAN card of the respective bidder along with their bid.
10. Sealed bids documents received in the tender box lying in the chamber of **The Sub-Divisional Officer, Ranaghat Sub-Division**, and will be opened on **29/07/2025 after 4-00 P.M.** in presence of quotationer or his representative who will be present to witness the opening of quotation documents.
11. Cutting / lifting of auctioned materials:
 - a. The successful bidder will have to take all type of precaution if needed such as shifting of existing any cable wire or electric line etc, shifting of any type of existing temporary structure at his own cost.
 - b. The successful bidder will have to clear the site at his own cost by lifting the trees within 07 (Seven) days after receiving lifting order from the department with due satisfaction of the **Sub-Divisional Officer, Ranaghat Sub-Division**.
 - c. The successful bidder will have to obtain transit pass after depositing fees prescribed for the purpose from the Range Officer, Ranaghat Range whichever is applicable for lifting of the materials.
 - d. The successful bidder have to repair any type of damage during execution of cutting or lifting work at his own cost if needed.
